

Consequent upon the joining of below named Candidate who has been appointed as Junior Engineer (Civil), UT Level in the pay scale Level-6 (35400-112400) vide Government Order no. 59-JK(JSD) of 2024 dated 07-03-2024 issued vide endorsement no. JSD-NGK/19/2024-01—JSD(7397236) dated 07-03-2024 notionally w.e.f 20.02.2024 and monetarily from the date of joining in the department, he is further adjusted/ posted as under against the available vacancy:

The appointment of the above candidate, as "Junior Engineer" (Civil) (as prescribed in the above said Govt. Order) shall further subject to the following conditions:

1. The appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification/Date of Birth/Reserved Category Certificates from the concerned issuing authorities is found fake/forged, his appointment as Junior Engineer (Civil) in the I&FC Department Jammu shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
2. That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the Domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government Services. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from

his salary. The DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishments of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.

3. The salary of the appointees shall not be drawn and disbursed to him unless satisfactory report in respect of genuineness of his qualification/Relevant Category Certificate/ Date of birth and other pre-requisite certificate(s) is received from the concerned issuing authority.
4. The inter-se-seniority of the appointee shall be determined in accordance with the merit secured by him in the selection list prepared by the J&K Services Selection Board and in terms of J&K Civil Services (Classification, Control and Appeal) Rules, 1956,
5. The appointment of the candidate shall be governed by the "New Pension Scheme as per SRO- 400 of 2009 dated 24.12.2009.
6. The candidate appointed under RBA and ALC/IB category shall be posted in such areas at least for 7 years.
7. The appointee shall be on probation for a period of two (02) years
8. The appointment of the above candidates shall be subject to outcome of writ petition(s), if any, pending before a competent Court of Law.
